

Terms and Conditions

Deposit Payment - Velorious requires the client to pay a deposit of 25% (twenty-five percent) of the cost of the trip to confirm each reservation. A reservation is not considered to be finalized until the deposit for the trip is received by Velorious. This deposit is nonrefundable.

Final Balance Payment - The balance of the cost of the trip must be paid in full no later than 8 weeks prior to the trip departure date.

Cancellation - If the client chooses to cancel the trip for any reason the following cancellation charges will apply:

- 8-4 weeks prior to departure date.....50%
- 4-2 weeks prior to departure date.....75%
- 2-0 weeks prior to departure date.....100%

Changes to the above may be made by Velorious, at the discretion of Velorious and dependent on each individual situation. Velorious may, for example, agree to credit a deposit to another trip, or to refund a deposit if Velorious feels circumstances are exceptional.

In the event of cancellation by Velorious, Velorious will repay in full all monies paid by the client. Velorious holds funds on trust deposit sufficient to provide security for repayment. The client has read the trip details as set out in Velorious' website and has been provided with full information about the trip. The contract between the client and Velorious will be governed by English law. Any matter or dispute in connection with this contract will be subject to the exclusive jurisdiction of the English courts.

Alterations - Velorious reserves the right to substitute at any time alternative accommodation or to make any other alteration to the trip which becomes necessary due to circumstances beyond its control and undertakes to inform the client as soon as possible.

Airport and Train Station Transfers - Certain Velorious trips include airport or train station transfers. All reasonable efforts will be made by Velorious to fill this part of the contract with the client. Velorious cannot be held responsible for cancellation of or delays to airline flights or train services. The client has been advised by Velorious to check the suitability of airline flights and/or train services prior to confirming flight/train reservations.

Responsibility of Participation - Velorious reserves the right to deny continued access to the trip to any client if his/her conduct is disruptive and/or affecting the enjoyment and safety of other clients on the trip. Velorious shall be under no liability for any extra cost incurred by such client as a result of their doing. Velorious requests that every client sign a Rider Responsibility form at the start of the trip.

Acknowledgement of Risk - The client acknowledges that he/she will be participating in an organized cycle tour with Velorious which will involve strenuous physical activity. The client confirms that he/she is sufficiently fit for, and is not suffering from any health problems which will be exacerbated by, such activity. The client has been advised by

Velorious to seek advice from a qualified medical practitioner if he/she has any doubts or concerns about his/her health or fitness.

The client recognizes that cycling on public roads, particularly in mountainous areas, is an activity with a danger of personal injury and even death. The client confirms that he/she is aware of and accepts such risk and will be responsible for his/her own actions and involvement in this activity.

The client acknowledges that he/she has been advised by Velorious to take out insurance against the costs of medical treatment, evacuation, loss of earnings and/or cost of care in the event that he/she suffer injury or illness during the tour and while traveling; against loss of or damage to his/her property (including bicycle); against liability he/she might incur to third parties; and against costs he/she might incur in the event of cancellation or curtailment of the tour or his/her participation in it. The client confirms that he/she will arrange adequate insurance against such risks prior to the departure date.

The client hereby agrees that neither Velorious nor its representatives or employees or agents will have any liability (whether in contract or in tort, including negligence) for any loss, damage, injury or death which the client may suffer in connection with this tour nor for any failure by the client to take out adequate insurance.
